Aalim School of Dance Policies and Other Important Information

Session dates, class times, and studios may vary. Be sure to check the classes page on albahira.org for full class schedules, studio information and class descriptions.

No refunds will be made after start of the session (or date of the workshop.) **No exceptions.**

Please make checks payable to **Aalim School of Dance.**

Because of the cumulative nature of the Level 1 Foundations curriculum, registration for **first-time beginners should register for the full session.** Missed classes can be made up by attending any other class at either Aalim School location, but make-up classes must be taken within the same session.

Aalim School of Middle Eastern Dance, LLC, its appointed instructors and substitutes, and the studios assume no responsibility for injury, theft or loss of property incurred during the classes, workshops, performances or other participation in class or related activity. **All students are required to sign a waiver statement,** and all students acknowledge that participation is at the student's own risk and that the above parties are not liable for injury, theft, or loss of property.

Individual classes can generally be purchased the day of class, space permitting, for returning students and/or in certain 60- and 90-minute classes. The single class rate is \$13.00 per class for the typical 90-minute classes, \$10.00 for 60-minute classes. (Specialty class pricing and individual class policies may vary.)

Make up classes must be taken within the same session. Only Gypsy cards can cross sessions. (See below.)

In the event that the instructor is unable to teach a class, a reasonable attempt will be made to find a substitute teach for the class. If a class must be cancelled due to instructor emergency or inclement weather, we will attempt to contact you first by email, and then by telephone, per the information provided on your registration form. Please be sure this information is legible, accurate, and up-to-date.

Classes are taught at two different locations, and in two different studios within the Minneapolis location building. Be sure to **check the studio designation for your class.**

Adult students of all ages are welcome.

Students under 18 welcome within guidelines. Students between the ages of 14 and 18 must have a release and permission form signed by a parent or legal guardian on file for each class session. Students under the age of 14 are required to get approval from the school director, Mirah Ammal, before enrolling. (Exception: classes specifically listed for children.) For students under 18, the Aalim School of Dance and its instructors or assigns do not take responsibility for the general care, safety, and behavior management of the child--this responsibility resides with the parent or legal guardian, and a signed waiver is required.

Register early - for the comfort and enjoyment of all students, **enrollment is limited.**

***What is a Gypsy card?**

Gypsy cards are designed especially for the continuing dance students to allow you the flexibility to register for a class session but to try out different classes or accommodate a busy schedule while still getting a price break over the single class drop-in price (\$13.00). 5-Class Gypsy cards are good for three months from the date of purchase or the first date of the new session for which you are registering (whichever is later). 10-Class Gypsy cards are valid for 19 weeks. Gypsy cards can be used for any regular 90-minute belly dance class at either Aalim School location. Similarly, "Raq" Gypsy cards are for 60-minute fitness classes.

Release and Waiver of Liability and Indemnity Agreement

(Read Carefully Before Signing)

In consideration of being permitted to participate in any way in the Dance Program indicated below and/or being permitted to enter for any purpose any restricted area (here in defined as any area where in admittance to the general public is prohibited), the parent(s) and/or legal guardian(s) of the minor participant named below agree:

1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below dance activity or event, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate. I understand and agreed that, if at any time, I feel anything to be UNSAFE, I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.
2. I/WE fully understand and acknowledge that:
 - (a) There are risks and dangers associated with participation in Dance events and activities which could result in bodily injury partial and/or total disability, paralysis and death.
 - (b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.
 - (c) These risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including, but not limited to, the Releasees named below.
 - (d) There may be other risks not known to us or are not reasonably foreseeable at his time.
3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death, however caused and whether caused in whole or in part by the negligence of the Releasees named below.
4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the dance facility used by the participant, including its owners, managers, promoters, lessees of premises used to conduct the dance event or program, premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions to engage in risk evaluation or loss control activities regarding the dance facility or events held at such facility and each of them, their directors, officers, agents, employees, all for the purposes herein referred to as "Releasee"...FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assigns, executors, heirs and next to kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO THE DEATH OF THE PARTICIPANT OR DAMAGE TO PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE.
5. I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
7. On behalf of the participant and individually, the undersigned partner(s) and/or legal guardian(s) for the minor participant executes this Waiver and Release. If, despite this release, the participant makes a claim against any of the Releasees, the parent(s) and/or legal guardian(s) will reimburse the Releasee for any money which they have paid to the participant, or on his behalf, and hold them harmless.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
